For the past 30 years the Ardmore Initiative has worked diligently to foster economic vitality in downtown Ardmore. We do this in a number of ways, including:

- Streetscape improvements and cleaning,
- Restoring the district's historic facades by providing grants,
- Creating new jobs for low to moderate income households through our business assistance grants,
- Decorating the district for the holidays, and
- Promoting Ardmore as a destination with special events

Our efforts have not only put more feet on the street in Ardmore but have the added benefit of increasing property values in part due to the historically low vacancy rates. And last year, the Ardmore Initiative stakeholders affirmed their confidence in Ardmore Initiative's work by reauthorizing the organization for 10 years.

We are proud of all we have accomplished in the past 30 years and excited to begin the next decade. Thank you to our volunteers, supporters, sponsors, and of course, the businesses who make us "Destination Ardmore."

ABOUT THE ARDMORE INITIATIVE

Founded in 1993, Ardmore Initiative (AI) has revitalized our community's historic downtown district through business assistance, advocacy, district marketing and events, streetscape cleaning and improvements, and much more. AI is proud to be a nationally accredited Main Street Program and former PA designated Keystone Communities Main Street. AI's programming is funded in part through a special assessment on the district's commercial properties. This organization has been resoundingly renewed five times since 1993 and is clearly a testament to our successful revitalization efforts.





- Since 1993, almost 200 new businesses have opened in Ardmore. Moreover in 2020 and 2021, during the pandemic, a total of 26 businesses opened in the district while only 7 closed for a net gain of 19 businesses.
- The Ardmore Initiative has awarded over \$230,000 of Community Development Block Grants through its business assistance grants for job creation and retention. In 2021 and 2022 these grants were awarded for job retention.
- The Ardmore Initiative has issued three rounds of the Downtown Dollars gift card program which put over \$100,000 back into the business district. The card, which is only accepted at participating businesses, supports The Ardmore Initiative's Shop Local strategies.
- The Ardmore Initiative has been a champion of revitalizing the downtown district through streetscape amenities for the past 30 years. We water and refresh 48 planters and 36 urns 3 times a year with seasonal plantings. In addition, The Ardmore Initiative funds sidewalk cleaning services and graffiti removal five to six days a week all year and every year resulting in almost 50,000 hours of cleaning time.
- Over 85 lighted A's and snowflakes have been purchased, installed, and maintained. Bike racks and benches have also been added to the downtown through fundraising and grant programs.

WINDOWS INTO HISTORY

a collaboration between the Ardmore Initiative, the Lower Merion Historical Society. the Lower Merion Conservancy, and the Township of Lower Merion, will help you see Ardmore in a new - or perhaps old - light. Throughout downtown, you'll be able to read about our 150-year history and view archival photos at (or near) their historic locations. Much has changed, but some things remain. Can you spot buildings that still exist today? Did your grandparents and great-grand parents walk down these same sidewalks? In honor of the Ardmore Sesquicentennial, visit the town you may

not remember, but is still right here. Picture yourself in the town as it was, celebrate all that it is, and imagine everything it could be.



THE MAIN STREET OF THE MAIN LINE









As part of the Ardmore Sesquicentennial celebration the Windows into History project was originally conceived by the Ardmore Initiative Streetscape Committee to enliven vacant storefronts. This project offers insights into Ardmore's 150-year history while creating a more inviting downtown shopping, dining, and pedestrian experience, in a way that speaks to the whole community.

After months of research by the partner organizations, digging through a treasure trove of archival binders and digital libraries of photos. newspapers, and documents, Ardmore Initiative Streetscape volunteer Jeff Mellin designed stunning sets of large format posters that were installed as triptychs in storefront windows. The multi-panel posters showcase images and stories, some sitespecific, some general, depending on location.

By the end of 2023, eight installations comprising 38 posters were installed throughout the downtown business district.

In 2023, the Ardmore Initiative spearheaded or supported events surrounding the Ardmore Sesquicentennial, including First Thursdays, Ardmore Historic Walking Tours, Ardmore Rock 'N Ride, ABA Ardmore Day, and more.



First Thursday Ardmore was created as a way to keep the businesses district vibrant with extended hours, special offers, and entertainment each month.



Fall for Ardmore returned to full capacity, hosting multiple food and drink vendors, merchants, activities, music, and more.



Historic Walking Tours through the downtown were organized to celebrate the Ardmore Sesquicentennial and as a way to promote the rich history of Ardmore.



Ardmore Restaurant Week was a successful, two-week celebration of the Ardmore dining scene, featuring 3-course prix-fixe menu at various price points.



Keystone Communities Facade Improvement Grant

Keystone Communities program grant to continue administering the Façade Improvement Grant Program in the Ardmore Business District. By providing matching grants of up to \$5,000, Al promotes rehabilitation of historic properties, educates stakeholders on proper design and maintenance, and alleviates the financial burden of façade renovation.



The Ardmore Initiative ended its 30th year of operation with financials that reflect the organization's strategic goals and initiatives. The organization has a long and successful track record of collecting nearly 95% of all assessments. Continued staff and Board efforts have driven additional revenue for the Business Improvement District through strategic sponsorship, fundraising and grant programs.

Grant revenue in 2023 includes the Façade Improvement Grant and Small Business Grant Program. Operating expenses focus on three main initiatives: business support and advocacy, economic development and marketing and streetscape beautification and cleaning. Throughout this period, Ardmore Initiative's operating revenue and expense were on budget. The chart featured presents a summary of Ardmore Initiative's unaudited Financial Statements for 2023.
